Resolution of the Governing Board of the Gold Ridge Fire Protection District DECLARING THE APPROPRIATION LIMIT for the 2018-2019 fiscal year.

WHEREAS, the purpose of complying with Article XIII B of the State Constitution, Government code Section 7900 and following, require an annual calculation of each district's appropriation limit for 1982-83 and succeeding fiscal years; and

WHEREAS, the documentation upon which such calculation is to be made for the 2018-2019 fiscal year has been available to the public for at least 5 days prior to the date of this meeting;

NOW, THEREFORE, BE IT RESOLVED that, for the purpose of making such calculation, this Board of the Governing Board of the GOLD RIDGE FIRE PROTECTION DISTRICT makes the following findings:

- (a) the "fiscal year" for which the appropriation limit is to be calculated is the 2018-2019 fiscal year;
- (b) The "prior fiscal year", i.e. the fiscal year immediately preceding the fiscal year for which the appropriation limit is to be calculated, is the 2017-2018 fiscal year;
- (c) The appropriation limit for such prior fiscal year is \$ 3,515,271

BE IT FURTHER RESOLVED THAT THIS BOARD MAKES THE FOLLOWING CALCULATIONS:

(TYL) This years limit.

(LYL) Last years limit.

(CPI) Consumer Price Index.

(P) Sonoma County Population Change

(LYL) $\$ 3,515,271 \times (\text{CPI}) 1.0367 \times (\text{P}) 0.9978 = (\text{TYL}) \underline{\$ 3,636,264}$

Fiscal Year 2018-2019 Prop 4 Limit \$ 3,636,264

Therefore, the APPROPRIATION LIMIT for the fiscal year 2018-2019 is estimated at this time to be \$ 3,636,264, and is based on the best available indices.
