A RESOLUTION OF THE BOARD OF DIRECTORS OF THE GOLD RIDGE FIRE PROTECTION DISTRICT APPROVING THE REORGANIZATION OF THE DISTRICT TO ANNEX THE TERRITORY OF SONOMA COUNTY SERVICE AREA NO. 40; ADOPTING A DISTRICT APPROPRIATIONS LIMIT; AND DELEGATING AUTHORITY TO THE BOARD PRESIDENT AND FIRE CHIEF TO EXECUTE NECESSARY DOCUMENTS TO COMPLETE THE REORGANIZATION

WHEREAS, effective January 25, 2022, pursuant to California Government Code section 56853, the Board of Directors of Gold Ridge Fire Protection District (“District”) and the Sonoma County Board of Supervisors (“County”) adopted District Concurrent Resolution 21/22-02 and County Concurrent Resolution 22-0031(collectively the “Concurrent Resolutions”) to jointly request and initiate proceedings pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, commencing with section 56000 of the California Government Code (“Cortese-Knox-Hertzberg Act”), with the Local Agency Formation Commission of the County of Sonoma (“Sonoma LAFCO”) for the consolidation of County Service Area No. 40 (“CSA-40”) territory and fire services agencies into and as part of a reorganization of the District (the “District reorganization”); and

WHEREAS, effective January 28, 2022, the District and the County entered into a Property Tax Allocation Agreement concerning real property tax revenue and other payments to provide supplemental funding for the District reorganization; and

WHEREAS, on November 30, 2022, pursuant to the Concurrent Resolutions, the District submitted its petition for reorganization, designated Application 2023-02, to Sonoma LAFCO; and

WHEREAS, on April 5, 2023, pursuant to California Government Code section 56150 et seq., after a noticed public hearing, Sonoma LAFCO adopted Sonoma LAFCO Resolution 2768, amending the District Sphere of Influence and approving the District petition for reorganization; and

WHEREAS, on June 7, 2023, pursuant to California Government Code section 57075, after a noticed public hearing, Sonoma LAFCO adopted Sonoma LAFCO Resolution 2774, finding insufficient protest, confirming, and ordering, without an election, the District reorganization; and

WHEREAS, on June 21, 2023, pursuant to California Government Code section 57202, Sonoma LAFCO recorded a Certificate of Completion with the Sonoma County Recorder, which officially established the effective date of the District reorganization; and

WHEREAS, at its regular meeting on July 5, 2023, the Board of Directors of the Gold Ridge Fire Protection District identified the need to take several executory steps to implement the District reorganization as approved by Sonoma LAFCO.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of the Gold Ridge Fire District approves and adopts Sonoma LAFCO Resolution 2768 for the District reorganization, including all provisions set forth in the District's petition filed with Sonoma LAFCO and the related supporting agreements between the County and the District.

BE IT FURTHER RESOLVED, that the Board of Directors of the Gold Ridge Fire Protection District approves and adopts a Fiscal Year 2023/2024 District appropriations limit of \$15,000,000.00, as set forth in the District's petition for reorganization and approved in Sonoma LAFCO Resolution 2768.

BE IT FURTHER RESOLVED, that the Board of Directors of the Gold Ridge Fire Protection District delegates authority to the President of the Board of Directors and the District Fire Chief to execute necessary documents and related agreements complete the District reorganization.



Resolution of the Local Agency Formation Commission of the County of Sonoma, State of California, Making Findings and Determinations, Determining Exemption from the California Environmental Quality Act, Approving a Reorganization of Territory Designated as: Gold Ridge Fire Protection District Reorganization No. 2023-02 (CSA 40) Involving Detachment of Territories From County Service Area 40 – Fire Services and Subsequent Annexation of That Territory, and Setting Protest Proceedings for the Proposal (File No. 2023-02)

RESOLVED, that the Local Agency Formation Commission of the County of Sonoma ("the Commission") hereby finds and determines as follows:

1. Proposal and Procedural History

1.1 The Gold Ridge Fire Protection District ("the District," or "the Applicant") filed a resolution of application ("the Application") with the Executive Officer of the Commission ("the Executive Officer") pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, Government Code section 56000 et seq. ("the Cortese-Knox-Hertzberg Act"), proposing a reorganization consisting of detachment of territories from County Service Area 40 – Fire Services (a dependent district of the County of Sonoma) and subsequent annexation of that territory ("the Proposal"). The territories that are the subject of the Proposal are areas served by active and inactive volunteer fire companies and one Incident Response Plan area ("the Affected Territory"). As part of the Application, the Applicant included a plan for providing services within the Affected Territory ("the Plan for Services"). The Application and the Plan for Services were submitted to the Executive Officer required by the Cortese-Knox-Hertzberg Act. The Executive Officer set the Proposal for consideration by the Commission and provided notice thereof as provided in the Cortese-Knox-Hertzberg Act.

1.2 The Executive Officer determined that the proposal was exempt from the California Environmental Quality Act pursuant to Sections 15320 and 15061(b)(3) of the State CEQA Guidelines.

1.3 The Executive Officer reviewed the Proposal and written comments received thereon and prepared a report analyzing the Proposal and recommending its approval ("the Executive Officer's Report"). Upon completion, the Executive Officer furnished copies of the Executive Officer's Report to all persons entitled to copies under the Cortese-Knox-Hertzberg Act.

1.4 The Commission considered the Executive Officer's Report and the Proposal at a noticed public hearing on April 5, 2023. At the hearing, the Commission heard and received all relevant oral and written testimony and evidence presented or filed and considered the Executive Officer's Report, the Proposal, and the CEQA determination. All interested persons were given the opportunity to hear and be heard.

1.5 At the conclusion of public testimony, the Commission discussed the Proposal and the environmental effects of the Proposal and voted to approve the Proposal, as set forth herein.

1.6 The Commission has reviewed and considered this resolution and hereby finds that it accurately sets forth the intentions of the Commission with respect to the Proposal.

2. CEQA Compliance

2.1 The Commission concurs with the Executive Officer's determination that the Proposal is exempt from CEQA under State CEQA Guidelines Sections 15061(b)(3) and 15320. The District will continue to provide fire and emergency medical services to the Affected Territory. It can be seen with certainty that the Proposal will not have a significant effect on the environment.

3. Cortese-Knox-Hertzberg Act Compliance

3.1 The Commission makes the following findings and determinations with respect to the Proposal.

- a. The affected territory is within the Gold Ridge Fire Protection District's sphere of influence, making it eligible for annexation.
- b. The reason for the reorganization is to allow residents of the affected territory to directly receive the full range of services provided by the District.
- c. The Municipal Service Review conducted for West County Fire and Emergency Services Agencies, the Municipal Service Review for Southern Territories of County Service Area 40 – Fire Services, and a Sphere of Influence Study for Portions of County Service Area 40 – Fire Services, reflects the District's ability to serve the affected territory.
- d. The District has executed a financial agreement with the County of Sonoma that will provide sufficient funding for the District to serve the affected territory.

3.2 The District has stated, and Municipal Service Reviews addressing the affected territories found, that the District can adequately serve the Affected Territories.

3.3 The Affected Territories have been determined to be inhabited, in that more than twelve registered voters reside within. Therefore, the Commission will

establish a Protest proceeding concluding at the Commission's regular meeting on June 7, 2023.

3.4 Based on the foregoing findings and determinations and the record of these proceedings, the Commission finds and determines that the Proposal is consistent with the intent of the Cortese-Knox-Hertzberg Act and the purposes of the Commission, as expressed in Government Code §§56001 and §56301. The Commission further finds, therefore, that approval of the Proposal is appropriate.

NOW, THEREFORE, based on the foregoing findings and determinations and the record of these proceedings, and pursuant to the Cortese-Knox-Hertzberg Act, the Commission hereby declares, and orders as follows:

1. The foregoing findings and determinations are true and correct, are supported by substantial evidence in the record, and are adopted as hereinabove set forth.

2. The Proposal is approved.

3. The Assessor Parcel Numbers comprising all of the parcels located within County Service Area 40 Incident Response Plan Area 81, Lakeville Volunteer Fire Company, San Antonio Volunteer Fire Company, Willmar Volunteer Fire Company, Two Rock Volunteer Fire Company, Bloomfield Volunteer Fire Company, Valley Ford Volunteer Fire Company, Bodega Volunteer Fire Company, Camp Meeker Volunteer Fire Company, and Fort Ross Volunteer Fire Company shall be as shown and described in Exhibit "A" to this resolution, attached hereto and incorporated herein by this reference.

4. The Proposal is assigned the following short-form designation: Gold Ridge FPD Reorg No. 2023-02 (CSA 40 Territories).

5. The regular county assessment roll shall be utilized for the Proposal.

6. The Affected Territory shall not be taxed for existing bonded indebtedness and contractual obligations.

7. The Executive Officer is authorized to file a notice of exemption in accordance with the provisions of CEQA and the State CEQA Guidelines.

8. If a certificate of completion for the Proposal has not been filed within one year after the adoption of this resolution, the Proposal shall be deemed abandoned unless, prior to expiration of the one-year time-period, the Commission authorizes an extension of time for completion of the Proposal.

9. The Clerk of the Commission is designated as the custodian of the documents and other materials that constitute the record of the proceedings upon which

**Resolution of the Local Agency Formation Commission of the County of Sonoma,
State of California, Finding Insufficient Protest and Confirming and Ordering
Without An Election A Change of Organization Consisting of: Gold Ridge Fire
Protection District Reorganization No. 2023-02 (CSA 40 Territories) Involving
Detachment of Territories from County Service Area 40 and Subsequent
Annexation of That Territory to the District (File 2023-02)**

RESOLVED, that the Local Agency Formation Commission of the County of Sonoma ("the Commission") hereby finds and determines as follows:

I. Procedural History.

1.1 The Gold Ridge Fire Protection District ("the Applicant") filed Application No. 2023-02 with the Executive Officer of the Commission ("the Executive Officer") requesting a change of organization consisting of annexation to the Gold Ridge Fire Protection District of territories detached from County Service Area 40 ("the Proposal"), generally located in western and southern regions of Sonoma County ("the Affected Territory").

1.2 At its meeting on April 5, 2023, the Commission considered the Proposal, conducted the required proceedings on the Proposal pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, Division 3 (commencing with Section 56000) of Title 5 of the Government Code ("the Cortese-Knox-Hertzberg Act"). The Commission approved the Proposal and adopted Resolution No. 2768, a copy of which is attached hereto as Attachment "A" and incorporated herein by this reference. Resolution No. 2768 directed that the Commission, or by delegation, the Executive Officer, initiate and conduct protest proceedings for the Proposal in compliance with the Cortese-Knox-Hertzberg Act.

1.3 The Commission conducted the duly noticed Protest Proceedings on the Proposal on June 7, 2023. At the hearing, the Commission's resolution making determinations was summarized. The Commission heard and received all relevant oral and written protests, objections, and evidence presented or filed. All interested persons were given the opportunity to hear and be heard. At the conclusion of public testimony, the Commission closed the hearing, determined the value of written protests filed against the Proposal and not withdrawn prior to the conclusion of the hearing, and voted to order the Proposal without an election, as set forth herein.

1.4 The Commission has reviewed and considered this resolution and hereby finds that it accurately sets forth the intentions of the Commission with respect to the Proposal.

2. CEQA Compliance.

2.1 Acting as the lead agency for the Proposal, pursuant to the California Environmental Quality Act ("CEQA"), the Commission, as part of Resolution No. 2768, found and determined, prior to reaching its decision on the Proposal, that the Proposal was exempt from the provisions of CEQA, under State CEQA Guidelines Section 15061(b)(3).

2.2 The Commission finds that it fully discharged its responsibilities under CEQA for the Proposal by its actions in Resolution No. 2768.

3. Cortese-Knox-Hertzberg Act Compliance.

3.1 The actions herein on the Proposal are being taken pursuant to the Cortese-Knox-Hertzberg Act.

3.2 The Proposal consists of a change of organization consisting of annexation to the Gold Ridge Fire Protection District of County Service Area 40 territories in Sonoma County, including Incident Response Plan area 81 and territories served by Lakeville, San Antonio, Willmar, Two Rock, Bloomfield, Valley Ford, Bodega, Camp Meeker and Ft. Ross Volunteer Fire Companies.

3.3 The parcels comprising the Affected Territory included in the Proposal are shown in Exhibit "A" of Resolution No. 2768.

3.4 The terms and conditions upon the Proposal shall be the terms and conditions specified in Resolution No. 2768.

3.5 The reason for the change of organization is to continue to provide fire and emergency medical services in the area in a sustainable fashion.

3.6 The short-form designation for the Proposal is: "File No. 2023-02: Gold Ridge Fire Protection District Reorganization No. 2023-02 (CSA 40 Territories)."

3.7 The value of written protests filed and not withdrawn is less than 25 percent of the registered voters residing within the Affected Territory or less than 25 percent of the number of owners of land owning less than 25 percent of the assessed value of land within the Affected Territory. In such cases, pursuant to Section 57075(a), the Cortese-Knox-Hertzberg Act directs the Commission to order the change of organization without an election.

NOW, THEREFORE, based on the foregoing findings and determinations and the record of these proceedings, the Commission hereby declares and orders as follows:

1. The foregoing findings and determinations are true and correct, are supported by substantial evidence in the record, and are adopted as hereinabove set forth.

2. The value of written protests filed and not withdrawn is insufficient to terminate proceedings or order the change of organization subject to a confirmation election, and the Proposal is therefore ordered without an election.

3. Subject to receipt of all charges assessed and fees due to the Commission and the State Board of Equalization, the Executive Officer is directed to prepare and execute a certificate of completion for the Proposal and to record a certified copy thereof with the Sonoma County Recorder. If the certificate of completion is not filed within one year after the Commission's approval of the proposal, the proceeding will be deemed terminated unless the Commission authorizes an extension of time for that completion.

3. The Clerk of the Commission is designated as the custodian of the documents and other materials that constitute the record of the proceedings upon which the Commission's decision herein is based. These documents may be found at the office of the Clerk of the Commission, 111 Santa Rosa Avenue, Suite 240, Santa Rosa, CA 95404.


